Sub: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 for Sale of company's investment in equity and preference shares of the associate company, World Resorts Limited to Nimbus India Limited, one of the Shareholders of World Resorts Limited (WRL)

We refer to our intimations dated August 18, 2023, December 06, 2023 and February 21, 2024 under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 in relation to our Board's decision for sale of Company's investment in equity and preference shares of its associate company, World Resorts Limited.

In accordance with the provisions of Share Purchase Agreement (for Preference Shares), the Company has on February 21, 2024 received the second tranche and the balance amount of Rs.25 Crores being the remaining 50% of the total sale consideration (net of taxes) from Nimbus India Limited towards sale of remaining preference shares of WRL and the Company has transferred the balance equivalent number of preference shares held by the Company in WRL in favour of the Purchaser on February 21, 2024.

Hence, in view of the above, the said transaction of sale of preference shares of WRL has consummated on February 21, 2024 upon receipt of the balance sale consideration by the Company (net of taxes) towards sale of remaining preference shares of WRL and transfer of all preference shares held by the Company in WRL in favour of the Purchaser.

Kindly take the same on record in compliance with the provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
